# What is Integrated Sustainability Management?

Environmental Management developed in the early '90s, facilitating improvement of business environmental performance.

CSR emerging in the late '90s renewed the agenda for corporate responsibility.

Sustainability management keeps focus on sustainability, in alignment with social viability and competitiveness. It is a development of management and leadership theory and practice.

It is a management response to several major considerations:

#### Sustainability is the real context:

Our world is decreasingly ecologically sustainable. Sustainability is now a fundamental condition of business and societal well-being - and is now the basic context for business.

#### Sustainability is strategic:

Sustainability Management is first a strategic issue. It cannot be an add-on, delegated to managers or left to specialists. With sustainability as the context, sustainability has to be integrated into corporate business strategy.

## Changing European and global regulations and developments:

Society responds to the sustainability context with more regulation and new 'asks' of business such as emissions trading. Business needs to be aware of European and international developments - and have a management approach that allows for positive, cohesive action.

#### The needs of good management:

Good management requires integration not only with systems for managing health, safety and quality, but more importantly with core business planning, management accounting, performance management processes. It also requires a cohesive response throughout the rest of the organisation.

#### Efficiency and competitiveness:

In meeting customer needs, business needs to manage resources efficiently and to competitive advantage.

#### The need for change of business culture:

As with other major changes to business organisation, for a grounded cogent response, there needs to be a change to the organisation's culture.

#### Human social needs:

Recognising people and their needs as important has always been a good insight into reality and what works well in business.

There was a particular focus on this within management development in the '50s through the '80s.
